2. Procurement Method is: Open International Bidding
3. Tenderers through their consortium/subcontracting/technical partner/alliance/association/cooperation or similar relationship who are domiciled in Botswana OR outside must, in order to be considered for the award of the contract, provide **proof of their SAP Certified Service Partner status (Procurement, Finance, Human Capital, Warehouse Management) and SAP Certified Pioneer Partner status.**
4. The tender is not open to State Owned Entities/Parastatals or any such entities wherein the Government has a stake/shareholding and any bids from such entities shall not be accepted.
5. Preference Margins will be applied to qualifying bidders in line with the following schemes:
 - 5.1. In accordance with Citizen Economic Empowerment Policy (CEEP) and where the bidder is a Non-Citizen Owned Entity, there is **mandatory 30%** subcontracting in both the value of the tender as well as the man-days to be consumed to a nominated citizen contractor sub-contractor **N.B Failure to comply with the mandate shall lead to disqualification.**
