- 2. Procurement Method is: Open Domestic Bidding
- Tenderers must, in order to be considered for the award of the contract, be registered with the Public Procurement Regulatory Authority [PPRA] in the following categories: Code: 319 (ICT Consultancy) Sub code: 01 (ICT System Development) AND Code: 120 (ICT Technical Support Services) Sub Code: 01 (System Development Services and Maintenance).
- 4. In the event that the bidder is a joint venture/ partnership/consortium there must be full adherence to all the compliance requirements by each constituent member of the joint venture/partnership/consortium and should be 100% Citizen Owned.
- This tender is reserved for 100% Citizen Owned companies in line with Section 76 of the Public Procurement Act.
